Regulations for English Proficiency Improvement Award for Students of the College of Life Sciences of National Chung Hsing University

- Passed at the College Executive Meeting (Bilingual Education Executive Committee) on Dec. 23rd, 2021
 The College of Life Sciences of National Chung Hsing University (hereinafter referred to as the College), to implement the bilingual learning program of the Ministry of Education, to improve the English proficiency of freshman students and to encourage students to take English tests, and specially stipulate the "Regulations for English Proficiency Improvement Award for Students of the College of Life Sciences of National Chung Hsing University" (hereinafter referred to as Regulations).
- 2. Applicability: Freshman students enrolled in the College from the 2021 academic year to take the English proficiency test listed in this Regulations (equivalent to the Common European Framework of Reference for Language-abbreviated in English as CEFR-level B2 and above). Students who meet the award standards at all levels may apply for awards based on their grades. Students from China, Hong Kong and Macau and foreign students are not eligible for the award.
- 3. Reward standards and amount:
 - (1) Students who meet any of the following criteria will be rewarded with NTD\$3,000.
 - I. NCHU (Freshman English Test) Post Test passed
 - II. TOEIC of 750 or above.
 - III. GEPT of High-Intermediate level (First & Second Stage)
 - IV. IELTS of 5.5 or above.
 - V. TOEFL iBT of 71 or above.
 - VI. TOEFL CBT of 197 or above.
 - VII. TOEFL ITP of 527 or above.
 - VIII. Cambridge English Qualifications: First Certificate in English (FCE).
 - (2) Students who meet any of the following criteria will be rewarded with NTD\$6,000.
 - I. TOEIC of 880 or above.
 - II. GEPT of Advanced level (First & Second Stage)
 - III. IELTS 6.5 or above.
 - IV. TOEFL iBT 83 or above.
 - V. TOEFL CBT 220 or above.
 - VI. TOEFL ITP 560 or above.
 - VII. Cambridge English Qualifications: Advanced and the Certificate in Advanced English (CAE) and above.
- 4. How to apply:

From April 8th to April 19th or from October 8th to October 19th of each semester every year. Applicants should prepare the following documents and apply to the College. Late application will not be considered. Adjustments will be further noticed.

- (1) Application form.
- (2) The original and photocopy of the test result (the original will be returned after verification, and the photocopy will be retained). If the name on the test result is in English, a certificate (such as a passport) to prove the English name should be attached for verification.
- (3) A photocopy of the cover of the applicant's account deposit book.
- 5. Reward standards at all levels is limited to one time per person and shall not be lower than the previous application standards. If one of the following circumstances occurs, no

reward will be granted.

- (1) Those who have received subsidies or awards for other English tests of the College for the proficiency test.
- (2) The English test result has been announced for more than two years.
- 6. The funds required for this Regulations are covered by the "Ministry of Education's Bilingual Learning Program Budget" and the "College's Annual Special Budget".
- 7. This Regulations will be implemented after being approved by the College Executive Meeting (Bilingual Education Executive Committee), and the same applies for amending.
